

Background of the State

- Uttar Pradesh is situated in northern India.
- Nepal is International boundary of the state. The state is bordered by Rajasthan to West, Haryana and Delhi to northwest, Uttarakhand to north, Bihar to east, Jharkhand to south east and Madhya Pradesh to south west.
- This is most populous state of India. It is the fifth largest state of India. It accounts for 6.88 percent of total area of the country.
- The population of the state was about 200 million as per census of 2011, which accounted for 16.49 percent of the total population of India.





Land Utilization in State

- Uttar Pradesh is an agriculture based state with total area of **2.42 crore Hectare**.
- Out of total reported area about 1.66 Crore Hectare is under cultivation
- Rest includes forest land 16.6 lakh hectare, barren land 4.57 lakh hectare, land fit for alternate uses other than agriculture is 28.93 lakh hectare, wasteland 4.19 lakh hectare, grazing and grassland 4.16 lakh hectare, fallow and uncultivated land 17.05 hectares.




